## NOTICE OF INTENDED DECISION

**I INTEND TO MAKE AN ORDER** under section 69 of the *PBA* that the **Pension Plan for the Employees of Komtech Enterprises Limited**, Registration **1046713** (the "Plan") be wound up effective **September 18, 2013**.

### **I INTEND TO MAKE THE ORDER FOR THE FOLLOWING REASONS:**

**There was a cessation or suspension of employer contributions to the pension fund.**

**Failure of employer to make contributions to the pension fund as required by the Act or the Regulations.**

**A significant number of members have ceased to be employed by the employer as a result of the discontinuance or reorganization of all part of business of the employer.**

**Such further and other reasons as may come to my attention.**

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the "Tribunal") pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Intended Decision is served on you.<sup>1</sup>**


