## NOTICE OF PROPOSAL

**I PROPOSE TO MAKE AN ORDER** under section 69 of the *PBA* that the **Retirement Plan for the Employees of Rieger Printing Ink Company Limited**, (the “Plan”), be wound up effective **October 15, 2008**, with such wind up to include the class of plan members and former members whose employment or plan membership terminated during the period July 30, 2008 to October 16, 2008.

### REASONS:

1. **There was a cessation or suspension of employer contributions to the pension fund.**
2. **The employer is bankrupt within the meaning of the Bankruptcy and Insolvency Act (Canada).**
3. **A significant number of members of the pension plan ceased to be employed by the employer as a result of the discontinuance of all or part of the business of the employer or as a result of the reorganization of the business of the employer.**
4. **All or a significant portion of the business carried on by the employer at a specific location was discontinued.**
5. **Such further and other reasons as may come to my attention.**

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the “Tribunal”) pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Proposal is served on you.**<sup>1</sup>
